# Details:

# DROP-OFF:

Thursday February 24<sup>th</sup>: Students should plan to come to school by car between 7:30 am-7:45 a.m. to begin check-ins with their teachers. It is important that you do not come before 7:30 as the school buses will be dropping off other students. Please plan to drop off your child with his/her luggage in the back of the school by the cafeteria. Students **may not** ride the school bus that day with their luggage. Chaperones should arrive no later than 7:15 a.m. to help with luggage and check-ins.

# PICK-UP:

Friday February 25<sup>th</sup>: Mrs. Lemons will send you a message through messenger about the ETA of the buses, but it should be between 3:00-4:00 p.m. Students will be released to parents in the cafeteria. Parents will be required to enter the building through the cafeteria doors. The teachers will have a sign-out sheet for checking students out at their designated table. *Note:* To pick a child up that is not your own, we must have written permission from the parent or guardian prior to leaving on the trip. It is critical that you DO NOT leave without signing your child out with their homeroom teacher.

# PURPOSE:

The purpose of the Environmental Study field trip is twofold:

1. We aim to teach an appreciation, understanding, and awareness of the natural world by studying and interacting with that world.

2. We also utilize the natural world as a stimulus for other learning and creative activities. Underlying the trip is the belief that learning is not restricted to the classroom. Rather, learning is found in the world around us; therefore, Rock Eagle bases their teaching in that world. It is believed that learning cannot be categorized into compact areas of knowledge but rather should be interrelated with each "discipline" augmenting its counterparts. Through the combination of related, multi-disciplinary activities and an interaction with the natural world, it is hoped that students not only will acquire new knowledge, but also will come to appreciate this philosophy.

#### **INSTRUCTION:**

A variety of activities and projects are prepared by the teachers and staff. The activities will be those learning experiences specifically applicable to environmental education, taking advantage of the natural surroundings of the area and using that environment as a stimulus for the acquisition of previously acquired skills. Activities will include the areas of reading and language arts, science, mathematics, art, health, physical education, and social studies.

#### **GROUP:**

The group will consist of fifth grade students at New Prospect Elementary School who have parental permission to join the trip, parent chaperones, teachers, and administrators. This number will be approximately 128. Any student unable to attend the trip will remain at New Prospect and have work to do with another adult in the building.

#### TRANSPORTATION:

Transportation to Rock Eagle will be provided by chartered buses which are licensed carriers approved for this type of trip.

# COSTS:

The cost for the trip is \$140.00. This will cover all expenses, including bus, food, snacks, and lodging. Students will not need any money to take on the trip unless they wish to purchase a small souvenir from the trading post (\$10- \$20 is recommended.)

#### **SUPERVISION:**

Responsibility for supervision and discipline will be assumed by the teachers, administrators, instructors and parent chaperones in attendance. The ratio of adults to students is 1 to 10.

# SHELTER:

Rock Eagle 4-H Center has cottages with five large bedrooms/bathrooms that accommodate four children, one bedroom/bathroom to accommodate two adult chaperones, and a living room area.

# LOCATION:

Rock Eagle 4-H Center is located off U.S. Highway 129 and 441, eight miles north of Eatonton, Georgia. It is easily accessible and is only 70 miles from Atlanta via Interstate 20 East.

# HISTORY:

Rock Eagle is named for a huge, winged, eagle effigy made by Native American people who inhabited the area centuries ago. These early tribes were superseded by other Native American civilizations. Today, Rock Eagle is the center of the Georgia 4-H Summer Camp and the 4-H Environmental Education Program during the school year. At other times of the year, the facility is open to public groups as an educational conference center.

# **RESOURCES AVAILABLE:**

The Center is beautifully situated on 1,500 acres of managed forest, featuring nature and hiking trails along with a well-stocked 100-acre lake for canoeing and aquatic study. The main complex includes a cafeteria-style dining hall, 54 cottages (each accommodating 18 people), five educational buildings, three recreational buildings, six open air pavilions, a primitive group camping area (with Adirondack shelters and log cabins), and a natural history building.

# **DINING HALL:**

Each meal is provided by the Rock Eagle Dining Hall. Breakfast may include juice, bacon, eggs, grits, toast, cereal, and milk. Lunch and dinner include one meat, two vegetables, rolls, choice of salad, dessert, and beverage. Food allergies or vegetarian meal alternatives MUST be indicated on the green permission slip (included with this packet).

#### **MEDICATION:**

If your child requires medication that they take at school normally or at home daily, make sure you fill out the pink form in this packet and return with the permission slip.

# ROCK EAGLE RULES

- 1. Stay in designated areas.
- 2. Be on time for all activities.
- 3. Be on time for meals. After each meal, put trays up and stay outside the cafeteria until the next scheduled activity. <u>Do not climb the trees.</u>
- 4. Electrical appliances may not be used in the bathrooms. (Use only in bedroom or living room.)
- 5. Alarms may not be set for earlier than 6:00 a.m.
- 6. Showers may not be taken after 9:30 p.m. or before 6:00 a.m.
