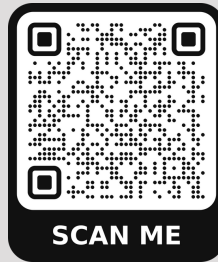
PARENTS:

ROCKIN' ON TO MIDDLE SCHOOL POOL PARTY WAIVER

5th Grade Pool Party Waiver

1. I agree to assume the risk of partaking personally and voluntarily by myself and, if applicable, my minor children in the use of the Facility, including, without limitation, any damages or injuries to person (including death) or property arising out of or in connection with use of the Facility. I further agree to personally and voluntarily assume the risk that myself and, if applicable, my minor children may be exposed to or infected by COVID-19 by using the Facility and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Facility may result from the actions, omissions, or negligence of myself and others, including but not limited to, other Members and Guests, the Association, its employees, agents, and representatives.

2. I agree to unconditionally waive, release, hold harmless and forever discharge the Association, its officers, directors, managers, agents and employees and their respective heirs, successors and assigns (hereinafter, collectively, the "Released Parties") from and against any and all claims for injury, damage, or loss sustained by me or, if applicable, my minor children, related to or unrelated to COVID-19 which may accrue or arise out of my or my minor child's use of the Facility (the "Released Claims"), including, but not limited to, any and all claims for negligence, personal injury, wrongful death, property damage, attorney fees, litigation costs or money damages of any kind which I may bring individually or which claims may be brought by my personal representative(s) or assignee(s), or which claims my minor children or their personal representative(s) or assignee(s) may bring.

I hereby give consent for my child _____ to participate in the 5th grade pool party on Thursday May 23rd 2024 at the Glen Abbey swimming pool. I give permission to allow my child to swim. I also hereby acknowledge that the children are swimming at their own risk, and I hereby release, waive, and covenant not to sue NPES PTA, Glen Abbey HOA or chaperones from any and all liability, claims or causes of action whatsoever arising out of any loss, damage or injury that may be sustained by the child during the pool party.
